

**Announcement
on the selection of an adviser for inclusion in the list
of qualified participants of the selection**

The basis for the selection

The procedure for selecting an adviser for inclusion in the list of qualified participants of the selection is established by the Law of Ukraine “On Privatization of State and Communal Property” (hereinafter referred to as the “Law”), the Procedure for involving advisers in the process of privatization of state-owned objects, approved by the Resolution of the Cabinet of Ministers of Ukraine of February 24, 2021 No. 134 “Some issues of involving advisers in the process of privatization of state-owned objects” (hereinafter referred to as the “Procedure”), the Regulations on the competitive commission for the selection of advisers in the process of privatization of state-owned objects, approved by the order of the State Property Fund of Ukraine of May 19, 2021 No. 839, registered by the Ministry of Justice of Ukraine of June 2, 2021 No. 726/36348 (hereinafter referred to as the “Regulations”), by the order of the State Property Fund of Ukraine dated 22.06.2021 No. 1075 "On making a decision on the planned selection of advisers for inclusion in the list of qualified participants of the selection".

Advisors cannot be persons defined in part two of Article 8 of the Law of Ukraine “On Privatization of State and Communal Property”.

Term and procedure for submission of selection documentation

Selection documentation must be submitted no later than at **17:00 of 12.07.2021**.

Selection documentation is submitted at the address: 18/9, Henerala Almazova St., Kyiv, 01133, the State Property Fund of Ukraine, daily from 08.00 to 17.00, on Fridays from 08.00 to 15.45, on pre-holiday days: from 08.00 to 16.00.

Supporting documents are submitted in a sealed opaque envelope with the inscription “Supporting selection documents”.

The envelope indicates the full name, location, code according to YeDRPOU (if any) of the participant of the selection and contact phone numbers.

Supporting documents are compiled in priority order specified in the announcement on the selection. The supporting documents’ description is attached to the supporting documents indicating the name of the document, the number of

pages and the selection criterion, the correspondence of which is confirmed by the indicated supporting document.

Content of selection documentation

Applicants submit the following selection documentation to the Fund:

- an application for participation in the selection in the form established by the Fund;
- supporting documents of selection.

The application must be drawn up in the form approved by the order of the State Property Fund of Ukraine of May 12, 2021 No. 775, registered by the Ministry of Justice of Ukraine of May 24, 2021 No. 679/36301.

The supporting documents of the selection are:

- a properly certified copy of the document confirming the authority of the person who signed the application for participation in the selection (in case of signing the application by an authorized representative);
- documents confirming the compliance of the participant with the selection criteria (paragraph 21 of the Procedure);
- extract from the commercial, banking, court register or other official document confirming the registration of a foreign legal entity in the country in which the head office of such a legal entity is registered and containing information about the location of such a person, the composition of participants (shareholders), the head (for legal entities — non-residents);
- information about ultimate beneficial owners. If the participant does not have ultimate beneficial owners, information about the absence and the reason for such absence is indicated.

Documents drawn up in a foreign language must be translated and in cases stipulated by law legalized in accordance with the procedure established by law.

Also, persons who have been sanctioned in accordance with the Decree of the President of Ukraine of May 14, 2020 No. 184/2020, which enacted the decision of the National Security and Defense Council of Ukraine of 14.05.2020 “On Application of Personal Special Economic and Other Restrictive Measures (Sanctions)” and the Law of Ukraine “On Sanctions” are not allowed to participate in the selection.
